

# Nomadano – ‘Share Your Travel Experience’ Contest Terms & Conditions

**Contest Period:** 12/17/2025 00:00 CEST to 12/31/2025 23:59 CEST

**Voting Period:** 12/17/2025 00:00 CEST to 12/31/2025 23:59 CEST

## 1. Eligibility

- 1.1. The Contest is open to natural persons aged **18 years or older** at the time of entry.
  - 1.2. Employees, contractors, and representatives of the Organizer, and their immediate family members, are **not eligible**.
  - 1.3. The Contest is **void where prohibited** or restricted by law. Entrants are responsible for ensuring their participation is lawful in their jurisdiction.
  - 1.4. By entering, you confirm you are the **sole author/owner** of the submitted content and have the full right to grant the license in Section 8.
- 

## 2. How to Enter

2.1. During the Contest Period, visit <https://pr.easypromosapp.com/p/997675> and submit a **travel story** about an **already completed trip**. Submissions must include:

- **Text narrative** (max. 800 characters).
- **Photo** (JPG/PNG).

2.2. Each entrant may submit **one** entry. Multiple entries beyond the limit may be disqualified.

2.3. **Theme compliance:** the story must describe a **real, past trip** and **authentic experiences**.

2.4. **Prohibited content:** hate speech, harassment, illegal activity, explicit sexual content, and any content violating third-party rights or applicable laws.

2.5. **AI-Generated Content Minimization:**

- Entries must be **original and based on the entrant’s own experience**.

- **Full-story generation by AI tools** (e.g., large language models) is prohibited.
  - **Permissible assistance:** light grammar/spelling fixes, basic image corrections (crop/exposure), and subtitles.
  - The Organizer may request **proof of authenticity** (e.g., raw media, EXIF data, additional context) and may disqualify entries suspected of being substantially AI-generated or fabricated.

### 3. Technical Requirements

3.1. Accepted file formats: **Images:** .jpg/.jpeg/.png;

3.2. Maximum sizes: **Text:** *800 characters*

3.3. Submissions containing **malware or harmful code** will be rejected.

---

### 4. Moderation & Publication

4.1. All entries are subject to **pre-moderation** for compliance.

4.2. The Organizer may **edit for length, clarity, formatting**, or to remove sensitive data, without altering the substance.

4.3. Approved entries may be published on the Nomadano website and social channels.

Publication does **not** guarantee eligibility or selection.

---

### 5. Community Voting

5.1. During the Voting Period, published entries may receive votes via website gallery voting mechanism

5.2. The Organizer may implement **anti-fraud measures** (e.g., CAPTCHA, rate-limits, email verification, IP/device fingerprinting) and may **invalidate suspicious votes**.

5.3. **Vote buying, automated voting, bots, scripts, or coordinated manipulation** are prohibited and may lead to disqualification.

---

### 6. Winner Selection

- 6.1. **Primary method:** the entry with the **highest number of valid votes** at the end of the Voting Period will be the **Community Winner**.
- 6.2. **Quality safeguard:** the Organizer reserves the right to appoint a **Jury Panel** to review the top [e.g., 10] entries for **authenticity, storytelling quality, relevance to theme, and rule compliance**, and to confirm or adjust the ranking if fraud or rule violations are established.
- 6.3. The Organizer may award **Honorable Mentions** at its discretion.
- 6.4. The Organizer's decisions are **final and binding**.
- 

## 7. Prize

- 7.1. **Grand Prize: €500 (five hundred euro)** to the Community Winner.
- 7.2. **Payment method:** bank transfer/PayPal within **30 days** of winner confirmation.
- 7.3. **Taxes & reporting:** Any **taxes, fees, exchange costs**, or **bank charges** are the **sole responsibility of the winner**.
- 7.4. The prize is **non-transferable, no cash alternative** except at Organizer's discretion.
- 7.5. If the winner cannot be contacted within 7 days or fails verification, the prize may be **forfeited** and awarded to the next eligible entry.

## 8. Rights & License

- 8.1. Entrant retains **ownership** of their content.
- 8.2. By submitting, entrant grants the Organizer a **worldwide, royalty-free, non-exclusive, transferable, sublicensable license to use, reproduce, adapt, publish, translate, distribute, publicly display and perform** the content, in whole or in part, for **marketing, editorial, and promotional purposes** related to Nomadano, in all media now known or later developed, for **[e.g., 3 years]** from submission (or **perpetual**, if you prefer).
- 8.3. Entrant warrants they have obtained **necessary permissions/releases** (e.g., identifiable people, private property) and that the content **does not infringe** third-party rights.
- 8.4. Entrant agrees to **indemnify and hold harmless** the Organizer from claims arising out of breach of these warranties.
- 

## 9. Personal Data & Privacy

- 9.1. The Organizer will process personal data (e.g., name, contact details, submitted content, voting data, device/IP data for fraud prevention) for **Contest administration, publication,**

**voting**, and **winner selection**.

9.2. Legal basis: **consent** (for publication), **contract/performance** (Contest administration), and **legitimate interests** (fraud prevention, analytics).

9.3. Data will be stored for 24 months and may be shared with **service providers** (e.g., hosting, anti-fraud, email, analytics) under appropriate data processing agreements.

9.4. Entrants have rights under applicable data protection laws GDPR: **access, rectification, erasure, restriction, objection, data portability**, and **withdrawal of consent**.

## 12. Limitation of Liability

12.1. The Organizer is not responsible for **technical failures, lost or late submissions, website outages**, or **incompatibilities**.

12.2. To the extent permitted by law, the Organizer's liability is limited to the **value of the prize**.

## 13. Dispute Resolution & Governing Law

13.1. These T&C are governed by the laws of **Poland**, without regard to conflict-of-laws rules.

13.2. Any disputes shall be submitted to the **competent courts of Warsaw, Poland**.

13.3. Consumers may have **mandatory local rights** that supersede parts of these terms.

## 14. Changes & Termination

14.1. The Organizer may **amend** these T&C or **cancel** the Contest due to force majeure, fraud, or factors beyond its control.

14.2. Material changes will be **posted** at [nomadano.com](https://nomadano.com) and take effect upon publication.
